Educational Institutions with effect from 01-01-2024 subject to the following terms and conditions:-

Terms & Conditions

1. The order for prior permission shall be valid for 2 (two) years only within which the applicant shall have to complete the construction works on its own land and run the School as proposed.
2. The School authority shall constitute the Managing Committee as per Section 12 of the Act.
3. The School authority shall have to fulfill all requirements as required under section 10 of the Act and Rule 7, 8, 9, 10, 11, 12, 13 and 14 of the Rules.
4. The School authority shall prepare a Scheme of Management as required under Section 14 of the Act and Rule 16 of the Rules.
5. The School authority shall apply for Registration of the School in Form- II within a period of 2 years alongwith the copies of all documents.
6. In case of failure to complete the task within the specific period of 2 (two) years, this Order shall stand cancelled.
7. The terms and conditions laid down in the Assam Non-Government Educational Institutions (Regulation and Management) Act, 2006 and Rules, 2007 is to be followed.
8. This permission will not accrue any financial liability to the BTC authority.

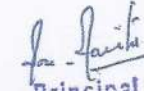
